The adhesive shall provide sufficient tack to retain the mounted pad to the fabric surface of the crotch of the undergarment. Each pad may be folded and shall be provided with a pull away cover, preferably environment friendly, for disposal of pads after use. ● The product shall be white in color for most of the areas and shall be free from unpleasant odor. It shall not contain any foreign matter such as dust and particulate matter.
