UNFPA hereby solicits a quotation for the following service:

"Accommodation and Meeting Package - UNFPA Retreat Bali, 12-17 February 2023"

UNFPA requires the provision of accommodation and meeting package in Bali, from 12-17 February 2023 for the above purposes.

Qualifications

- Must be a minimum 4-star hotel/resort, located in Gianyar District (Kabupaten Gianyar), Bali province
- Must have a meeting room that can accommodate minimum 50 meeting participants (with various possible seating arrangements and includes hybrid meeting setup)
- Must have an outdoor space for team building exercise/outbound that can accommodate minimum 50 participants within hotel/resort area or walking distance
- Preferably located within an area that has options of restaurants

III. Eligible Bidders

This Request for Quotation is open to all eligible bidders; to be considered an eligible bidder for this solicitation process you must comply with the following:

- A bidder must be a legally-constituted company (in form of hotel or resort) that can provide the requested services and have legal capacity to enter into a contract with UNFPA to perform in the country, or through an authorized representative.
- A bidder must not have a conflict of interest regarding the solicitation process or with the TORs / Technical Specifications. Bidders found to have a conflict of interest shall be disqualified.
- At the time of Bid submission, the bidder, including any JV/Consortium members, is not under procurement prohibitions derived from the <u>Compendium of United Nations Security Council</u> <u>Sanctions Lists</u> and has not been suspended, debarred, sanctioned or otherwise identified as ineligible by any <u>UN Organization</u> or the <u>World Bank Group</u>.
- Bidders must adhere to the UN Supplier Code of Conduct, which may be found by clicking on <u>UN</u> <u>Supplier Code of Conduct</u>.

IV. Content of quotations

Quotations should be submitted in a single email whenever possible, depending on file size. Quotations must contain the price quotation, to be submitted strictly in accordance with the price quotation form provided, duly completed and signed by the bidding company's relevant authority and submitted in PDF format.



V. Instructions for submission

Proposals should be prepared based on the guidelines set forth in Section III and IV above, along with a properly filled out and signed price quotation form, and are to be sent by email to the contact person indicated below no later than: Wednesday, February 1st 2023 at 23:59 Jakarta Time¹.

Please note the following guidelines for electronic submissions:

- The following reference must be included in the email subject line: RFQ Nº UNFPA/IDN/RFQ/23/001 -Accommodation and Meeting Package - Bali 12-17 February 2023. Proposals that do not contain the correct email subject line may be overlooked by the procurement officer and therefore not considered.
- The total email size may not exceed **20 MB (including email body, encoded attachments and headers)**. Where the technical details are in large electronic files, it is recommended that these be sent separately before the deadline.
- Any quotation submitted will be regarded as an offer by the bidder and does not constitute or imply the acceptance of any quotation by UNFPA. UNFPA is under no obligation to award a contract to any bidder as a result of this RFQ.

VI. Overview of Evaluation Process

Quotations will be evaluated based on the technical proposal and the total cost of the services (price quote).

The evaluation will be carried out in a two-step process by an ad-hoc evaluation panel. Technical proposals will be evaluated for technical compliance prior to the comparison of price quotes.

VII. Award Criteria

In case of a satisfactory result from the evaluation process, UNFPA intends to award a Guarantee Letter to the Bidder that obtain the lowest-priced technically acceptable offer.

VIII. Right to Vary Requirements at Time of Award

UNFPA reserves the right at the time of award of contract to increase or decrease, by up to 20%, the volume of services specified in this RFQ without any change in unit prices or other terms and conditions

IX. Payment Terms

UNFPA payment terms are net 30 days upon receipt of invoice and delivery/acceptance of the milestone deliverables linked to payment as specified in the contract.

X. Fraud and Corruption
