#### III. Content of quotation

Quotations should be submitted in a single e-mail whenever possible, depending on file size. Quotations must contain:

- Price quotation, to be submitted strictly in accordance with Price Quotation Form and must be signed by the company's relevant authority and submitted in PDF format.
- a) Copy of legal documents (establishment in Indonesia)

#### IV. Instructions for submission

Quotations should be prepared based on the guidelines set forth in Section III above, properly filled out and signed, to be sent by e-mail to indonesia.office@unfpa.org no later than: Sunday, July 19<sup>th</sup> 2020 at 23:59 Jakarta Time<sup>2</sup>.

Please note the following guidelines for the submission:

- The following reference must be included in the email subject line: RFQ № UNFPA/IDN/RFQ/20/008 Laptop. Proposals that do not contain the correct email subject line may be overlooked by the
  procurement officer and therefore not considered.
- The total email size may not exceed 20 MB (including email body, encoded attachments and headers).
   Where they are in large electronic files, it is recommended that these be sent separately before the deadline.

#### V. Overview of Evaluation Process

Quotations will be evaluated based on the compliance with the technical specifications (Annex IV) and the total cost of the goods (price quotation).

### VI. Award Criteria

UNFPA shall award a Purchase Order to the lowest priced bidder whose bid has been determined to be substantially compliant with the bidding documents.

#### VII. Right to Vary Requirements at Time of Award

UNFPA reserves the right at the time of award of contract to increase or decrease by up to 20% the volume of goods specified in this RFQ without any change in unit prices or other terms and conditions.

### VIII. Payment Terms

UNFPA payment terms are net 30 days upon receipt of shipping documents, invoice and other documentation required by the contract.

#### IX. Fraud and Corruption

UNFPA is committed to preventing, identifying, and addressing all acts of fraud against UNFPA, as well as against third parties involved in UNFPA activities. Failure to fully cooperate with investigations will be considered sufficient grounds to allow UNFPA to repudiate and terminate the Agreement, and to debar and remove the supplier from UNFPA's list of registered suppliers.
