IV. Content of quotations

Quotations should be submitted in a single e-mail whenever possible, depending on file size. Quotations must contain:

- a) Price quotation, to be submitted strictly in accordance with the price quotation form.
- b) Copy of legal documents (establishment in Indonesia).

Both parts of the quotation must be signed by the bidding company's relevant authority and submitted in PDF format.

V. Instructions for submission

Quotations should be prepared based on the guidelines set forth in Section IV above, along with a properly filled out and signed price quotation form, are to be sent by e-mail to indn.bids@unfpa.org no later than: **Tuesday, May 25th 2021 at 23:59 Jakarta Time².**

Please note the following guidelines for electronic submissions:

- The following reference must be included in the email subject line: **RFQ N^o UNFPA/IDN/RFQ/21/008 - Laptop**. Proposals that do not contain the correct email subject line may be overlooked by the procurement officer and therefore not considered.
- The total e-mail size may not exceed **20 MB (including e-mail body, encoded attachments and headers)**. Where the technical details are in large electronic files, it is recommended that these be sent separately before the deadline.
- Any quotation submitted will be regarded as an offer by the bidder and does not constitute or imply the acceptance of any quotation by UNFPA. UNFPA is under no obligation to award a contract to any bidder as a result of this RFQ.

VI. Overview of Evaluation Process

Partial bid is allowed / bidder is allowed to participate only for 1 lot or for all lots, however must be for full quantities of each lot. Quotations will be evaluated based on the compliance to the requirements stated in the RFQ document and the price quotation.

The evaluation will be carried out in a step by step process by an ad-hoc evaluation panel:

Lot 1:

1. All documents set forth in Section IV received by the deadline
2. Goods quoted are product of Japan manufacturers
3. Technical:

Quotation will be evaluated only for bidders whose submission of the above (1) and (2) satisfied:

The part of price quotation stating the technical specification of quoted goods will be evaluated for requirements compliance (technically acceptable offer) prior to the comparison of price quotes, in accordance with the below:

- a. Yes: meet the requirements
 - b. no: does not meet the requirements or no information provided to assess compliance with the requirements
4. Price quotes will be evaluated (for comparison) only for bidders who obtained "yes" of the above (3). Price comparison of price quotes will be conducted, with recommendation to the lowest price quote.

Lot 2:

1. All documents set forth in Section IV received by the deadline
2. Technical:
Quotation will be evaluated only for bidders whose submission of the above (1) satisfied:
The part of price quotation stating the technical specification of quoted goods will be evaluated for requirements compliance (technically acceptable offer) prior to the comparison of price quotes, in accordance with the below:
 - a. Yes: meet the requirements
 - b. no: does not meet the requirements or no information provided to assess compliance with the requirements
3. Price quotes will be evaluated (for comparison) only for bidders who obtained “yes” of the above (3).
Price comparison of price quotes will be conducted, with recommendation to the lowest price quote.

VII. Award Criteria

In case of a satisfactory result from the evaluation process, UNFPA intends to award a Purchase Order to the Bidder(s) that quote the lowest-priced technically acceptable offer for each lot, whose bid has been determined to be compliant with the RFQ documents.

VIII. Right to Vary Requirements at Time of Award

UNFPA reserves the right at the time of award of Contract to increase or decrease by up to 20% the volume of services specified in this RFQ without any change in unit prices or other terms and conditions.

IX. Payment Terms

UNFPA payment terms are net 30 days upon receipt of invoice and delivery/acceptance of the milestone deliverables linked to payment as specified in the Long Term Agreement.

X. Fraud and Corruption

UNFPA is committed to preventing, identifying, and addressing all acts of fraud against UNFPA, as well as against third parties involved in UNFPA activities.
