### IV. Content of quotations

Quotations should be submitted in a single e-mail whenever possible, depending on file size. Quotations must contain:

- a) Price quotation, to be submitted strictly in accordance with the price quotation form.
- b) Copy the availability of ISO 13485 or ISO 9001 QMS certificate for the products required.
- c) A signed and dated Declaration of Conformity (DoC) according to ISO 17050 stating compliance to the relevant ISO standards and directives (e.g., CE self-declaration 93/42/EEC), and which has a reference to the offered product
- d) Provide a product catalogue, information of medical device registration and supporting letter from distributor is a plus.
- e) Copy of legal documents (establishment in Indonesia).

Price quotation must be signed by the bidding company's relevant authority and submitted in PDF format. After the closing date (RFQ submission deadline), if required, the bidder(s) will be contacted for clarification.

### V. Instructions for submission

Please note the following guidelines for electronic submissions:

Proposals, including both technical and financial proposals, that do not contain the correct email subject line may be overlooked by the procurement officer and therefore not considered.
- The total e-mail size may not exceed **20 MB (including e-mail body, encoded attachments and headers)**. Where the technical details are in large electronic files, it is recommended that these be sent separately before the deadline.
- Any quotation submitted will be regarded as an offer by the bidder and does not constitute or imply the acceptance of any quotation by UNFPA. UNFPA is under no obligation to award a contract to any bidder as a result of this RFQ.



## **VI. Overview of Evaluation Process**

Quotations will be evaluated based on the compliance to the minimum specification requirements stated in the Annex 2 and the price quotation.

The evaluation will be carried out in a step-by-step process by an ad-hoc evaluation panel.

For each Lot:

1. All requirements set forth in Section IV received by the deadline.
2. Bidder(s) quotes will be processed for price comparison. The bidder who quotes the lowest price will be requested to provide a sample of each product offered.
3. Evaluation on specification of sample of product(s) submitted by bidder resulted of number (2) above, to determine:
  - Yes: meet the expected requirements
  - No: does not meet the expected requirements
4. If the answer of the above number (3) is “no” then repeat number (2) for the next lowest bidder.

## **VII. Award Criteria**

In case of a satisfactory result from the evaluation process, UNFPA intends to award a Purchase Order to the Bidder that quote the lowest priced technically acceptable offer, whose bid has been determined to be compliant with the RFQ documents.

## **VIII. Right to Vary Requirements at Time of Award**

UNFPA reserves the right at the time of award of Contract to increase or decrease by up to 20% the volume of goods specified in this RFQ without any change in unit prices or other terms and conditions.

## **IX. Payment Terms**

UNFPA payment terms are net 30 days upon receipt of invoice and delivery/acceptance of the milestone deliverables linked to payment as specified in the contract.

## **X. Fraud and Corruption**

UNFPA is committed to preventing, identifying, and addressing all acts of fraud against UNFPA, as well as against third parties involved in UNFPA activities.
