Background:	The COVID-19 pandemic in Indonesia, which began on March 2, 2020 continues to be our problem and challenge. Hard work is being done by both government and non-government parties. The Indonesian government established a Task Force for the Acceleration of COVID-19 Response through Presidential Decree (Keppres) Number 9 of 2020, which amended the initial Presidential Decree Number 7 of 2020 concerning the Task Force for the Acceleration of COVID-19 in response. Then on July 20, based on Presidential Decree No. 82 of 2020, the Government formed the Committee for the COVID-19 Response and National Economic Recovery (or KPC-PEN). In addition, non-governmental actors work hand in hand with civil society organizations, philanthropic institutions including faith-based institutions, business networks, media, academics, international institutions, international-national- and local non-governmental organizations, including the community to collaborate and contribute in handling COVID-19. At the same time, we also understand that Indonesia as a disaster-prone region will continue to face disaster management challenges.	
	Realizing that the hard work of handling COVID-19 and other disasters is a major work carried out not only by the Government but multi-stakeholder efforts from the community at grassroot level to ministries/agencies at the central level as well as non-government actors, 2021 the President assigned the Coordinating Ministry for Human Development and Culture as the Coordinator of the Solidarity and Generosity Movement for Covid-19 Response and other Disasters on August 2, 2021. To that end, the Coordinating Ministry for Human Development and Culture together with various other stakeholders formed the Coordination Team of the Solidarity and Generosity Movement to ensure and encourage this movement to be effective and beneficial to the people of Indonesia by the Decree of the Coordinating Ministry for Human Development and Culture (Kemenko PMK) Number 34/2021.	
	In disaster management, information management is the key to effective coordination. There have been various websites/reports issued by various ministries/agencies, but there has not been a coordinated effort of information management that produces information management products for the purposes of comprehensive reporting and coordination.
